## Smart Little Scotty 2011 breeding contract.

This agreement is by and between Rockhampton Equine Breeding Centre, hereinafter referred to as Stallion Agents and

\_\_\_\_\_ hereinafter referred to as Mare Owner.

The Stallion Agents hereby agree to breed the Stallion **Smart Little Scotty**, AUS Registration No.: Q-25751, AmQHA #2868800 with chilled semen or live cover, to the mare \_\_\_\_\_, Registration No.: \_\_\_\_\_ at the service fee of \$1,650.00 including GST.

The Mare Owner agrees to pay the following fees for services pursuant to this agreement as follows:

1. A initial payment of \$550.00 is payable on signing and acceptance of this contract and is non-refundable and deductible from the breeding fee. The \$550.00 booking fee will be payable to D & L Baker Holdings Pty Ltd.
2. The balance of the breeding fee, being \$1100 will be payable upon confirmation of the mares pregnancy. (Up to 45 days) For mares being handled at The Rockhampton Equine Breeding Centre, the balance of the breeding fee will be payable when the mare is picked up. All fees associated with this contract are to be paid in full prior to picking up the mare.
3. Refunds: Should the stallion be unable to be collected or semen become undeliverable, the stallion agents reserve the right to refund the service fee less the deposit. (\$1100)
4. The stallion agents will collect the first collection of chilled semen at no charge to the mare owner to send to approved vets. The freight is the mare owners expense. Additional collections will be sent at the mare owner's expense of \$242 per collection plus freight.
5. Mares being bred at the Rockhampton Equine Breeding Centre will not be charged collection fees. Other fees associated with housing and breeding of the mare maybe payable. View fees at [www.rebc.com.au](http://www.rebc.com.au)
6. A live foal guarantee is given with one return privilege the following season. It is understood that should the foal die within its first 7 days , the Mare Owner will be entitled to a return privilege. The Stallion Owners must be notified within 48 hours of the foal's death and provide a vet certificate. A different mare will be allowed to breed the following season for a return privilege in place of the original mare at the stallion agents discretion. A return fee of \$275 will apply for mares bred at Rockhampton Equine Breeding Centre or a collection fee of \$242 plus freight will apply to mares requiring chilled transported semen.

D & L Baker Holdings Pty Ltd, or handlers shall not be liable for any sickness, disease, injury or death, which may be suffered by the Mare or her progeny.

When the Stallion Agent and the mare owner sign one copy of this Contract, it will then be a binding Contract on both parties.
